The undersigned agrees to abide by all Pennsylvania Game Laws and to defend, indemnify and hold harmless the Borough of Sewickley Heights, its officials, employees and agents (collectively, the "Borough"), and the owner(s) of any property on which the undersigned is authorized to hunt, from and against any and all claims, demands, suits, debts, actions, liabililities, damages, losses, causes of action, judgments, costs and expenses of any nature whatsoever in law of equity (collectively "Claims") suffered or incurred by the Borough in connection with hunting in the Borough. The undersigned, for himself or herself, and for his or her heirs, personal representatives and assigns, hereby releases and forever discharges the Borough from any and all Claims for bodily injury or property damage arising from or occurring during the undersigned's participation in hunting in the Borough, including without limitation any damages or injury arising from or relating to the care, custody or control of real property in the possession of the Borough.

The undersigned acknowledges that this Agreement has been carefully read and that the contents hereof are fully understood. The undersigned further acknowledges that the execution of this Agreement is a free act and deed and indicates voluntary acceptance of all terms set forth herein.
